

# FORAGE ESTABLISHMENT, FORAGE, FORAGE SEED, and PASTURE

If any of the following situations apply to you, refer to the corresponding example on the reverse to complete your Seeded Acreage Report (SAR).

## Example 1: Forage Seeded in 2024

All acres of spring seeded perennial ryegrass, tame forages, forage seed, and pasture that were seeded in 2024 have been pre-printed in the crop column of your 2025 SAR. Please review these fields and make any changes to acres, crop type, or intended use (i.e. forage, forage seed, or pasture) for 2025.

For forage crops, please indicate the forage type based on the following composition of stand:

Alfalfa – 75% or more alfalfa Alfalfa Grass – 25% to less than 75% alfalfa Grass – 75% or more grass Sweet Clover – 75% or more sweet clover Coarse Hay – 25% or more native grass

For forage seed, please indicate whether it is pedigreed alfalfa seed, common alfalfa seed, tall fescue seed, perennial ryegrass seed, pedigreed timothy seed, or common timothy seed.

If the establishment field has been destroyed, please draw a line through the crop and mark it "destroyed". If only a portion of the acres have been destroyed, please record the acres that remain as per the above instructions.

### **Example 2: Existing Forage and/or Forage Seed Fields**

If you were insured with MASC last year, your forage, forage seed, and pasture acres will be printed on your SAR based on last year's information.

Please review this information to ensure it is correct for the 2025 crop year. If the intended use or composition of stand has changed, please indicate the changes. If the field has been destroyed or if you are no longer farming the field, please draw a line through it and mark it as "destroyed" or "no longer farming". If you are farming newly acquired fields that are not listed on your SAR, please record the legal description, crop type, variety, acres, and establishment year.

New forage insureds, plus a number of producers that were insured in 2024 may have their forage and forage seed acres inspected by MASC this spring. The information from the inspection forms (as provided by the adjustor) should be transferred to your SAR before you return it to MASC.

For forage seed producers, pedigreed timothy seed, and pedigreed alfalfa seed must be a variety that is certified as pedigreed in Canada and crop certificates must be made available if requested. All common alfalfa seed varieties are insurable provided the ground cover is greater than 75 per cent. Common timothy seed is not insurable.

#### **Example 3: Pasture Insurance**

If you selected pasture as an insurable crop in conjunction with Select Hay Insurance or Basic Hay Insurance, you are required to declare your livestock numbers by June 30. Please record all of your livestock by category in the pre-printed section on the last page of your SAR.

This report must be filed with MASC by June 30, 2025, unless you have an Excess Moisture Insurance claim or have aerial seeded crops, in which case your SAR must be filed by June 22. If your SAR is not returned by June 30, 2025, then: i) a \$500 late filing fee may be charged, ii) all crops will be inspected for insurability; and iii) the cost of the inspection will be charged to your account. This report must be signed and returned or completed online whether or not acres have been seeded.
