

COMPLETING YOUR PASTURE DAYS SPRING DECLARATION

The deadline for filing your Pasture Days Spring Declaration is **June 30**. Please use these instructions to ensure the declaration is completed accurately (see reverse for a completed example). You can mail, fax, or deliver your declaration in person to MASC.

Section 1: Livestock - The livestock type, category, and number you declared in 2024 (fall declaration), or if you are a new applicant, the information you reported on your Pasture Days Application form are pre-printed.

Section 2: Livestock Declared Grazing on Pasture in 2025 - Please indicate the livestock type, category, date put on pasture, and number of animals put on pasture. Any changes in livestock numbers can be listed in this section. Please list animals separately if put on pasture on different dates.

Livestock Types:

Bull:	Breeding bulls
Open Cow:	Dry cow, fall calvers or bred heifers (on pasture)
Cow/Calf:	Cow with or will have a calf on pasture
Yearling:	Stocker, heifers, steers, and immature (non-breeding bulls)

Section 3: Supplemental Feed Provided to Livestock since placing them on Declared Summer Pasture If livestock have been placed on permanent summer pasture and you have provided supplemental feed (e.g. bales) while they are on pasture, indicate the date supplemental feed began, the date supplemental feed ceased, the type of feed (e.g. hay, grain, etc.), the amount of supplemental feed in pounds, the livestock type (e.g. cattle, sheep, etc.), the livestock category (e.g. cows with calves), and the number of livestock that were fed.

Supplemental feed provided to livestock after they were turned out to pasture must be reported to MASC immediately.

Section 4: Pasture Acres Located on the Following Legal Descriptions - The legal description and pasture acres you reported are pre-printed. Draw a line through any legal description and acres if you no longer own or operate this pasture. If you have acquired new pasture acres, add the legal description, the type of pasture (tame, native, or woodland¹) and the number of acres.

Declaration - Read the declaration, date, and sign the form.

Note: If your livestock numbers or declared pasture acres change, or if you must provide supplemental feed after filing this report, or if your livestock have been moved to an undeclared field, please complete the enclosed Pasture Days Change form, and submit it to MASC as soon as possible.

If you require assistance to complete your Pasture Days Spring Declaration, please contact MASC.

¹ **Tame or seeded pasture**: grazeable land that has been improved from its natural state by seeding, draining, irrigating, fertilizing, or weed control.

Native pasture: areas used for pasture that have not been cultivated and seeded, or drained, irrigated, or fertilized. Includes native pasture/hay and rangeland used for grazing.

³ Woodland for pasture: grazeable bush, forest land, and bushy areas (but not dense forest) used for grazing.
