SEEDED ACREAGE REPORT / HAIL APPLICATION

The following items are included in this package:

- 1) Seeded Acreage Report (SAR) (grey insert)
- 2) SAR instructions, along with information on grade guarantees and seeding deadlines
- 3) Forage Establishment, Forage, Forage Seed, and Pasture SAR instructions (green insert)
- 4) MASC's New & Noteworthy that includes important information on submitting your SAR online, acres too wet to seed, broadcast and aerial seeding, and pedigreed seed crops (blue insert)
- 5) Application for Hail Insurance (beige insert); producers with the Continuous Hail Insurance Option (CHIO) selected do not require a hail application as Hail Insurance coverage has already been selected
- 6) Hail Insurance risk areas, instructions, and rates
- 7) Return envelope

SAR Reporting Deadline

If you have acres that are too wet to seed, you must complete and return your SAR by June 22 (June 23 for 2025) to file an Excess Moisture Insurance claim without penalty. Excess Moisture Insurance claims will not be accepted after June 30.

If you have seeded any crop by airplane or helicopter, you must complete and return your SAR by June 22 (June 23 for 2025) in order for it to be eligible for Agrilnsurance on the applicable acres.

The deadline for filing your SAR is June 30. Crops and acres can only be added for insurance coverage or deleted after June 30 if an inspection is completed by MASC at your expense. Please ensure your SAR is completed accurately using the enclosed example and instructions. You can mail, fax, complete online, or deliver your SAR in person to MASC. For your convenience, your SAR can be completed online or placed in the service centre drop box. MASC recommends considering Canada Post Registered Mail or Xpresspost as options to ensure a timely submission of your SAR.

If your SAR is not returned by June 30, a \$500 late filing fee will be charged, and all of your land will be inspected to determine insurability. You will be required to pay the cost of the inspection.

Hail Insurance

If you wish to purchase Hail Insurance, apply online at **masc.mb.ca**, or complete the enclosed application and return it by mail, fax, or drop it off at MASC. You can also apply for Hail Insurance by telephone. Once MASC approves the application, a Statement of Hail Insurance will be sent to you. Hail Insurance is effective at noon on the day following application.

If you have selected the CHIO, you will not receive a hail application as you automatically have Hail Insurance for all the eligible crops listed on your SAR. A Statement of Hail Insurance confirming these crops will be sent to you once your SAR is processed. Hail coverage for the eligible crops commences as soon as the crop emerges. If you want Hail Insurance on any crops not covered under CHIO or not selected as Optional CHIO Crops, you **must** complete a separate hail application. If you are unsure if you have CHIO or Optional CHIO Crops selected, please contact MASC or review your coverage selections online at **masc.mb.ca**.

This report must be filed with MASC by June 30, 2025, unless you have an Excess Moisture Insurance claim or have aerial seeded crops, in which case your SAR must be filed by June 22. If your SAR is not returned by June 30, 2025, then: i) a \$500 late filing fee may be charged, ii) all crops will be inspected for insurability; and iii) the cost of the inspection will be charged to your account. This report must be signed and returned or completed online whether or not acres have been seeded.

SEEDED ACREAGE REPORT INSTRUCTIONS

The circled letters on the example of the Seeded Acreage Report (SAR) correspond to the letters A to K in the instructions below. Please follow these instructions when completing your SAR. Be sure to complete information for all legal descriptions.

Contact MASC for assistance if any of the following conditions apply to your contract:

- a) seeded any fields by airplane or helicopter
- b) reseeded a crop and filed a claim on that crop
- c) seeded a new stand of forage in fall 2024 or spring 2025 (with or without a companion crop)
- d) seeded an annual crop for greenfeed, pasture, or swath grazing
- A) Your MASC Service Centre contact information is listed here.
- B) In this area, indicate yes or no if you: seeded any fields by plane or helicopter; seeded any forage (for hay, seed, or pasture) this spring or last fall; intend to seed greenfeed after filing this report (if applicable); intend to harvest any crops for pedigreed seed production (if applicable); seeded any crops for organic production (if applicable); plant potatoes for seed production (if applicable). If you have seeded any crop by plane or helicopter, you must complete and return your SAR by June 22 (June 23 for 2025) in order for it to be eligible for Agrilnsurance
- C) Check all of the **legal descriptions** listed. Land farmed in a bordering province or state must also be listed. For land you are no longer farming, draw a line through the legal description and write "Delete Land" in the "Crop/Forage/Unseeded" column. The land will be removed from your contract and will not preprint on next year's SAR. For land you are not farming only for this year (for example, in rotation with another producer), write "unused land" in the "Crop/Forage/Unseeded" column. It will preprint on next year's SAR. **Add land** by writing the legal description in the next available row on the form. Be sure to leave enough blank lines to list all the fields on each legal description. If there is not enough room to list all of your fields on a quarter section, re-write the legal description below the pre-printed legal descriptions and list the remainder of the fields. If more space is required or if you are adding land with shares, contact MASC for a blank form or to make the necessary contract changes. **Pre-printed crops –** forage and forage seed crops may be pre-printed. If these crops are pre-printed, please ensure they are correct.
- D) **Previous Year's Declared Acres** indicates the number of acres reported on each legal description in the previous year. This includes forage acres, pasture, seeded acres, summerfallow, and acres too wet to seed.
- E) In the column marked "Summerfallow Acres", indicate the total number of summerfallow acres on each legal description.
- F) Indicate the total number of acres that are too wet to seed as of June 20 on each legal description. Please note that the deadline for filing an Excess Moisture Insurance claim, without penalty, is June 22 (June 23 for 2025). If some acres were too wet to seed as of June 20 and subsequently seeded after June 20, the acres should be listed as seeded and too wet to seed.
- G) List all **crops and varieties** on a field-by-field basis. You must include all insurable and non-insurable crops and varieties. If a field covers two or more quarter sections, split the field as closely as possible into the respective quarter sections. Be sure to list all the annual crops seeded and all of your forages, regardless of whether they are for hay, pasture, or seed. If you seeded a forage crop or perennial ryegrass in 2024, your crops and acres will be printed based on our most recent information. Refer to the enclosed Forage Establishment, Forages, Forage Seed & Pasture instruction sheet and complete any necessary revisions. **Note:** Be sure to list your crops accurately to ensure you have the correct coverage. If you have a pedigreed seed crop selected for insurance and you are growing that crop for pedigreed seed production, you must write the word "pedigreed" beside the crop type or your coverage will be considered to be non-pedigreed. For producers who selected organic coverage, the word "organic" must appear beside the crop type. You must also indicate the type of corn (silage, grain, or open pollinated) and the type of potatoes (table, irrigated processing, or dryland processing) and if the potatoes are intended for seed production. **These crop designations can only be revised after the June 30 SAR deadline under limited circumstances.**
- H) Write in the date of the last day of seeding (e.g. May 20) for each field. However, if some acres of a field are seeded after the seeding deadline or during the Extended Coverage Seeding Period (refer to enclosed 2025 MASC-Insurable Crops, Grade Guarantee & Seeding Deadlines), those acres must be reported as a separate field and the seeding date indicated. Do not record seeding dates for established perennial forage.
- I) List the seeded acres for every field of each crop seeded. Each variety of crop must be listed as a separate field even if two (or more) varieties of the same crop are seeded adjacent to each other on the same quarter section. The total number of acres must be listed for land seeded on a share basis. For Strawberry and Saskatoon Establishment Insurance, list the plant count in this column.
- J) If applicable, your **unit number and crop share** are listed on any legal description farmed on a crop share basis. If you are farming more land on a crop share basis with a landlord, you must contact MASC.
- K) Once you have completed the SAR, carefully read the declaration on the bottom of the form, and then date and sign the last page of the form. Please make a copy for your records. Mail your SAR in the enclosed return envelope, fax it, or drop it off at MASC. Remember the deadline for receipt of the form at MASC is June 30. Note: MASC will mail you a Statement of Insurance upon receiving and processing your SAR. Please review the statement and contact MASC if you have any concerns.
