- ❑ Report any wildlife damage to crops

## OCTOBER/NOVEMBER

- ❑ Pay AgriInsurance and Hail Insurance premiums
  - Deadline (interest-free): October 31
- ❑ File Harvested Production Report
  - Review how-to YouTube videos
  - Deadline: November 30
- ❑ Review Excess Moisture Insurance coverage
  - Deadline to make changes is November 30

## DECEMBER/JANUARY

- ❑ Annual Review
  - Insurance specialist to discuss upcoming program changes, crop dollar values, and review coverages
- ❑ Get to Know Your Service Centre
  - Meet your service centre's loan specialist, client service representative, office administrator, and adjusting team leader
